Delayed twice, Panagal fest in Feb now

AFTER two postponements, the district administration has decided to perform Panagal festival on a grand note in February. The historical place of Panagal is located on the outskirts of Nalgonda town and it comes under Nalgonda municipality. Earlier, the district administration had announced two different months and dates in the month of February and April to perform the Panagal festival for three days. However, the decision was postponed twice for various reasons by the district administration. In view of Mahashivaratri, the district administration has decided to conduct Panagal festival on February 16.

Tourism department has sanctioned ₹25 lakh and archeology department has sanctioned ₹21 lakh for the festival. District administration has made new cement road to Pachala Someswara temple from the main road. On directions of district collector, officials concerned have given the contract to construct toilets, water tank, development of park and compound wall to the museum.

At present, works are in progress at proposed celebration area. In Panagal, there are Pachala Someswara Swamy and Chaya Someswara Swamy temples having national identity for uniqueness in construction and historical background.

They were built during Kakatiya and Chalukya kings' period.

The state has established a museum in half an acre on Pachala Someswaraswamy temple premises where excavated unearthed collections have been stored.

Another Karimnagar man falls prey to clinical trials

Clinical trials claimed the life of a man in Nagampeta village in June

MOTHER of 27-year-old Chiluveri Ashok Kumar of Kothapalli village near Jammikunta town of Karimnagar district, who suffered serious health issues after undergoing clinical drug trial conducted by a Bengaluru-based pharma company in Hyderabad recently, lodged a complaint against the company with Jammikunta police on Tuesday.

It may be recalled that clinical drug trial claimed the life of a person in Nagampeta village in June. Vangara Nagaraju (39) died due to complications after clinical drug trials in Bengaluru.

According to sources, Ashok Kumar stopped graduation due to poor financial condition of his family.

He worked as sales executive in the circulation wing of a daily. In

the meantime, he went to Hyderabad and came in contact with people who were part of clinical trials of the pharma company.

About two months ago he returned to his native village and started behaving abnormally. He even tried to kill his mother.

His condition came to light when he tried to destroy the agreement documents signed with the company. However, his sister managed to retrieve a few

of them and when she went through the documents she was shocked to learn that her brother was part of a clinical trial.

Meanwhile, Ashok's mother took him to a Darga in Jammikunta and Arepalli in Warangal. When his brothers Shyam Kumar and Kishore Kumar in Warangal enquired about his health condition, he told them the entire story how the laboratory conducted clinical trials on him for two months. They took the help of a local social activist Shaik Shabir Ali and visited Nagampeta to meet the kin of Nagaraju who died in June after clinical trials. They found that it was the same company which conducted trials on Ashok.

Jammikunta CI P Prasanth Reddy told his family members that they would take local doctors' suggestion and approach court for further action.

Attack on Dalits: Abhangapatnam accused likely to surrender in court

AS search operations by police intensified to trace the whereabouts of Dalit victims as well as the accused in the incident at Abhangapatnam of Naveepet mandal, it is suspected that there is a chance of the accused surrendering in court in the coming few days.

Political parties are maintaining silence, and Dalit organisations have intensified their agitation for the arrest the accused and release of Dalit victims from his camp.

Sand transporter B Bharath Reddy, a native of Abhangapatnam threatened two Dalits of the village in September and a video appeared on social media two weeks ago. Considering Dalit organisations' representation, police registered a case and started an investigation following which the victims and the accused disappeared from the village. Dalit organisations alleged that the victims were

kidnapped by the accused. Police officials are also expressing similar doubts. According to police reports, the accused is regularly changing his sim cards and it has become difficult to trace his location through mobile signals. Police suspect that the accused and the victims are camping in a farmhouse in the suburbs of Hyderabad.

Hyderabad, Cybarabad and other districts police are busy in providing security to VIPs in coming few days and it became difficult to Nizamabad police to utilise their counterparts' help to arrest the accused and release the victims from the camp. Police came to know that the accused had filed a quash petition in High Court which will take some time to come for hearing. They suspect that he may surrender before the court along with the two victims in Hyderabad or Nizamabad.

Senior Congress leader and former minister P Sudarshan Reddy visited the victims' families and inquired the situation.

Viral video

M Bharat Reddy, reportedly a BJP member, in September humiliated two Dalit youths who had allegedly questioned him over illegal mining of gravel. A video of the incident went viral, landing him in trouble. Police registered a case against Reddy, but he went absconding. The two youths could not be traced either.
