₹5,500 cr for sugar industry to avert Kairana fiasco in '19

With an eye on the upcoming Assembly polls in five States this year and Lok Sabha polls in 2019, the Narendra Modi Government on Wednesday approved a ₹5,500-crore package for the sugar industry.

This includes over twofold jump in production assistance to cane growers and transport subsidy to mills for export up to 5 million tonnes the marketing year 2018-

The total package is of '5,538 crore, of which '1,375 crore pertains to transport subsidy to millers and the remaining amount will be credited directly to sugarcane growers as production assistance. This has come a day after the UP Govt announced a slew of measures for sugar cane farmers and set November 30 as the deadline for private sugar millers to settle cane dues. This is the third incentives to politically significant sugarcane sectors in the past four months.

For poll transparency, EC to procure VVPATs

In a move to ensure greater transparency during the polls, the Election Commission (EC) has decided to procure Voter Verifiable Paper Audit Trail (VVPATs) for all polling stations for the upcoming Lok Sabha elections in 2019.

For a smooth electoral process, the EC has begun preparation 13 months in advance. About 50 per cent of the groundwork has been completed as the EC has begun work ahead of schedule.

As many as 9.45 lakh units have been produced by the Bharat Electronics Limited

Electronics Corporation of India Limited (ECIL), Hyderabad till date. The remaining VVPAT units (8 lakh) will be manufactured and supplied to the various States/UTs comfortably before end of November 2018. The Commission had placed an order of 17.45 lakh VVPATs to these two Public Sector Units The Commission said the poll panel would like to allay any unfounded apprehensions

regarding the supply of VVPATs for the Lok Sabha polls in 2019. Even as 17 political parties want the Lok Sabha polls to be conducted on paper ballots and

the polling body has made improvements in VVPAT machine design to rule out any

malfunctioning.
According to sources, the EC is taking extra care this time to avoid any glitches in the EVM machines and the update comes after the embarrassing situation in Gondia and Kairana bypolls where many VVPAT design faltered on over exposure to heat and light. In other cases, the paper roll had absorbed humidity and failed to move smoothly in the VVPAT system.

The EC also stated that the enhanced the requirement of per cent to 135 considering the rend of failure rate of VVPATs in past elections.

The Commission has estimated 171 per cent Ballot Units, 125 perent Control Units and 135 VVPATs requirements for upcoming Lok Sabha elections. "In case of any error in VVPAT, only VVPAT is replaced with the reserve one, wĥereas, in case of anv error in Ballot Unit or Control Unit of the EVM, entire set of Ballot Unit(s), Control Unit and VVPAT is changed, resulting in an increase in requirement of VVPATs than the requirement of Control Units of EVMs," it

Sources in the EC said special care will be taken of VVPAT

machines - anti-humidity thermal paper rolls have been procured, which will be used in high-humidity polling stations. "These highly absorbent thermal paper rolls will ensure uninterrupted voting in humid areas. The heat-and-light problems will be addressed by way of special hoods that the new VVPATs will come with," said the sources.

For the 2019 Lok Sabha elections, the polling staff will get trained on how to handle the new M3 EVM and the VVPAT machines correctly and as per protocol, so that malfunctions due to human error are minimised.
