E-Auction bidding Terms and Conditions

- Computerized e-Auction shall be conducted by Service Provider on behalf of Phoenix, on prespecified date, while the bidders shall be quoting from their own offices / place of their choice. Internet connectivity and other paraphernalia requirements shall have to be ensured by bidders themselves.
